MLM Companies do NOT care nor have any interest what so ever where any Sponsored accounts comes from or fall under. Again, they are structured wrong or by intention. And unless the activity (Spill Over) of that PROFESSIONAL is under you or right above you, it is NOT going to benefit YOU.

QUESTION:

When was the last time YOU received a serious "Residual" income via: "other people's work" or "sale" and/or: using your "Replicated Link"?

FACT: Only LESS THAN 1% succeeds in MLM.

There are many types of compensation plans such as a "Forced Matrix" out there that pays a percentage on each level based on "other people's sales efforts". Beyond the industry problem of people's; inability, reluctance, and unavailability to SELL; those types of comp plans can easily be out of industry compliance because it usually has a non self-sustaining factor primarily due to ATTRITION (people failing and dropping out).

NOTE: What is interesting about these MLMs is that when one performs an evaluation of their compensation plans, they have the same common fundamental characteristics (flaws) as current MLMs that have not been shut down - recruitment-driven, top-weighted, and financed primarily by personal consumption of participants. So all MLMs are vulnerable to regulatory action should law enforcement focus on the fundamental flaws in their systems, rather than on the behavior of participants. *Source: Dr. Jon M. Taylor, Ph.D. of: Consumer Awareness Institute (CAI).

MLMs can never equalize into profitability the way companies in the real world can, so that the result will be that the organization as a whole cannot, even in theory, be profitable. When this

inevitable destiny occurs (due to ATTRITION), the only money to be made is not from the product or service but from the losses of people <u>lower</u> down in the organization.

***Don't get us wrong, we know good pyramid structures OR Forced Matrixes can be sound, but for the most part, NOT for the typical 3rd PARTY MLM Compensation Plans. Pyramid comp plans are intrinsically unstable.

TeamVinh: Replicated Link (RL): Primarily used by: TeamVinh PROFESSIONALS, Leaders, and our Internet Gurus to generate and enroll "Orphan" Accounts. *After the Orphan is transferred, the Orphan becomes a "PE" and this PE will be "Sponsored" by the TeamVinh Member who purchased the VPAK. Then ALL future Volume (commission & residual \$) from this PE benefits its Sponsor. **The Sponsor further benefits when this PE purchases more VPAKs and gets more PE's under them and so forth (Optimum Duplication).

Maximum VPAK Orders: This Limit ensures that all TeamVinh Members gets its proportionate and fair share of the global growth of TeamVinh.com and MLM Success.

Immediate Commission PAID: For each Orphan Generated – depending on which Plan you are on, you are paid immediately for each Orphan.
