The Vice Chancellor of the University of Bamenda informs GCE A' Level Candidates and the public at large that admissions are opened into the UBa/MBS Professional Education Center for entrance into the International Professional Programs as follows::

Duration of the Programs:

- 3 years for a Degree level international professional qualification (Starting with A Level/Baccalauréat).
- 1 additional year for a Master's degree level international professional qualification.

NB: the International Professional Programs can be shorter to complete depending on the level of exemption granted to HND holders and University Graduates.

Applications are granted on a first come first served basis, and early applications are encouraged to secure admissions on these extremely competitive programs. Please note that **late application will be accepted until 12 September 2013 and will attract an additional fee of 10 000 CFA Francs.**

Exam fees are payable per paper and are remitted to the international examination board.

How to make the payments:

ALL FEES MUST BE PAID THROUGH THE COLLEGE'S BANK ACCOUNT.

Entry Requirements:

- GCE Advanced Level or relevant Baccalaureat (Students may apply while awaiting their GCE Result in order to secure their space. Admitted candidates will be required to submit their GCE/Baccalaureat results slip later for registration).
- HND/University Degree from a State University or State recognized Private University. (Exemptions MAY be granted to students with first degrees or higher in relevant fields of studies)
- Ability to study and sit international exams in the English Language

Application Procedure:

- A Hand written application addressed to "the Director of UBa/MBS Professional Programs" and mentioning the program the applicant is intending to study.
- Proof of payment of CFA 25,000 representing non-refundable application fees.
- 4 Passport size photographs
- Certified Copies of the last certificates obtained (Students may apply while awaiting GCE Advanced level results, but full admission will be granted on presentation and verification of CGE Advanced level results)
- Proof of ID (Certified copy of the National ID Card or the Birth Certificate)
- A hand written authorization for minor students.
- Evidence of English language proficiency (For non-native English speakers)
