Analysis as part of the possibility of the impeachment process against Donald Trump.

"Endangering the lifes of others and Lying by « voluntary » omission.

1- D. Trump tested positive for Covid-19 since September 16, 2020?

A source close to the White House says: "Donald Trump was tested Covid-19 positive on Wednesday, September 16, 2020. This test was confirmed at the PCR on Saturday 19 September 2020. »

As of that moment, Donald Trump no longer required Joe Biden to submit to a doping test. 2- Why could D. Trump no longer hide his illness from Covid-19?





5- Donald Trump definitively stated Covid-19 Negative on the basis of an unreliable test?

6- Conclusion:
